1. Bidder must submit the original authorized service & dealership certificate in Godrej letter pad from M/s. Godrej & Boyce Mfg. Co. Ltd., alongwith Xerox copies of PAN & GSTN.
2. Only sealed and signed tenders on the prescribed format accompanied by the Earnest Money Demand Draft for Rs.25,000/- (Rupees twenty-five thousand) only drawn in favour of Secretary, Angul United Central Cooperative Bank Ltd., Angul payable at Angul shall be considered.
